
#### **ARCHIE MESSERSMITH-BUNTING**



# HOW TO HAVE DIFFICULT CONVERSATIONS

Being able to ask for help is an essential life skill. But for some people, it is a skill that they have great difficulty using. Asking for help is a much more complex process than we may realize and there is a dangerous assumption in life that those who don't ask for help don't need help. Asking for help requires that a person:

- 1. Realizes there is a problem
- 2. Knows they need help with the problem
- 3. Knows who can help
- 4. Knows how to ask for help

Some problems you can identify right away, like a big angry dog running toward you or forgetting where you've parked your car. Many other problems sneak up on you, like anxiety that slowly creeps up over months until you're too paralyzed to get out of bed. It's not always clear when a situation has turned into a problem, and you can't get help if you don't know that you need it.

Problem situations aren't always universal or easy to define, and it's not always clear when a situation has turned into a problem. Generally, whatever the issues are, when they get in the way of your ability to function, to get through the day, then there is a problem.

If you have a problem but already know how to fix it, and have everything that you need to do that, then you don't need assistance. You actually only need help when you don't know how to fix it, can't do it alone, or you've tried and your solution didn't work.

Having a problem is not the same thing as needing help. There's also a big difference between needing help and wanting help, and that's another distinction that can be difficult for some. For example, those who put pressure on themselves to be perfect might not want help or feel like they don't need it no matter how much they do. Some people are so deeply depressed and filled with negative thoughts that they don't believe they deserve help.

When it comes to confronting someone about your concerns for them, there is one very important rule to remember—approach from a place of caring and support or don't approach at all. Ultimatums rarely work, "interventions" not led by a trained mental health provider most often have the opposite effect, isolating and angering the

person you are trying to help. Go with love or don't go at all.

People who have had a bad experience seeking help in the past will also be less likely to want help, and a lot less eager to seek help even when they might really need it. A "bad helping experience" is one where:

- They felt embarrassed asking for help
- They were ridiculed for needing help
- They broke an invisible 'asking for help' rule such as asking the wrong person at the wrong time or in the wrong place, or asking too often
- They were reprimanded for having a problem
- They experienced overload from the help (everyone freaked out)
- Getting help led to something unpleasant like an involuntary hospitalization or inadvertently made the problem worse

There are also unwritten rules about asking for help, not to mention the invisible social contract that forms between the helper and the one needing assistance.

- Is it okay to ask for help?
- Will I owe something to the person who helps me?
- What will asking for help cost me?
- Will they think less of me for needing help?

Knowing who you should approach to get the help you need isn't enough. You need physically to get yourself in contact with them—knowing where they are, how to get there, and how to contact them.

Once you've decided to reach out for help, you still must be able to let them know what your problem is, any steps you've taken to try and solve it, and the outcomes of those attempts. Plus, you need to do all of that in a way that will allow the person actually to give you the help that you're after. The help they offer also must be in a form that you can use and understand. It may sound simple but fear, anxiety, depression, difficulty with communication, and difficulty talking about and/or labeling emotions can all interfere with this step.

Regularly staying in contact with people in your life helps create a safety net that makes asking for help easier. Checking in with those around you can help you spot the early signs of a potential problem in those you care about while giving them the opportunity to support you when you need it. Having a social support network is a vital lifelong protective factor against mental health issues, making these difficult conversations in life easier to handle.

#### Introducing the 2022 Ordo Honoris recipients

Recognizing the notable achievements of alumni is an important part of fraternity history. Until 1982, there was not a formal way to recognize alumni beyond an occasional biography in the *Quill & Scroll*, or a personal appearance at a National Convention. Then, Executive Director Donald Stohl, Zeta '54, created the *Ordo Honoris* and presenting it to the National Board of Directors. The *Ordo Honoris* is an opportunity for the outstanding achievements of our Brothers to be recognized and to serve as an inspiration for current and future members.

Ordo Honoris recipients often cite the early and lasting impression of the KDR Brotherhood, which helped them in their personal and professional development.

Membership in *Ordo Honoris* is in the hands of one's peers. Each convention year individual Chapters, alumni organizations, or individual Brothers in good standing submit nominations. Nominees must demonstrate exceptional personal or professional accomplishments, community involvement, or outstanding national or Chapter involvement with the Fraternity. The nominee

provides a letter of acceptance of the nomination along with a complete biography. The *Ordo Honoris* Selection Committee, consisting of current *Ordo Honoris* members, receives the names of the nominees and their biographies to review and makes the final selections. Alumni selected for induction receive their recognition medal and plaque at the *Ordo Honoris* Banquet at the biennial National Convention.

#### **BROTHER TIMOTHY W. CHRISTY, RHO '74**

Brother Christy, a BS Mechanical Engineering cum laude graduate of Lafayette College, had a distinguished 39year career in GE's Power business, serving the world's utilities and energy companies on all the continents as an international Field Engineer, Service Sales Manager, and Global Sales Programs Executive. As an undergraduate, Tim was active in the Rho Chapter as the Commissar of the House Dining Services for two years from 1972 to 1974, making sure all the Brothers were well-fed—a monumental task! He was also active in the Engineering Honor Societies Pi Tau Sigma as president and Tau Beta Pi as a member.



The service mentality instilled by KDR led Tim to be active in the community after college: leading 15 young men including his 3 sons to the highest rank of Eagle Scout as Scoutmaster in Niskayuna NY, serving as Vice President of the Saint Helen's Elementary Catholic School Board of Directors, and coaching youth hockey, baseball,

basketball, and soccer. Upon Tim's 2013 retirement from GE he and his wife established and personally funded the Manito Learning Center (http://www.manitolearningcenter. org) in the Philippines hometown of his wife, Leda, which serves up to 100 underprivileged students each year focusing on math, English, and computer skills. Due to the large voltage variations from the local utility, Tim engineered a 3kw solar electric supply system for the school to enable the computers to operate reliably.

In 2015, they secured 501(c)3 non-profit status for the Center, which allowed them to expand the school thru the support of additional donors and provide scholarships to Filipino college students pursuing careers in STEM majors (Science, Technology, Engineering, and Math) to drive innovation, problem-solving, and critical thinking for the future of the Philippines.

#### **BROTHER BRIAN L. DILTS, THETA '84**

Brother Dilts received his degree in Mechanical Engineering Technology from Purdue University. As



an undergraduate, he was involved in the leadership of the Chapter serving as House Manager and then as Junior Tribune. After graduation he began his career with Cummins Engine Company and gained experience at Cummins for five years with total responsibility for the design & release of the

Marine 300B boat engine, which is the same engine used in all Ram Pickup trucks. In 1989, Brian continued his professional career at Tobar, Inc and retiring in 2020. While at Tobar, Inc he excelled and was recognized as the "Most Valuable Employee" for being responsible for growing the international rubber seal company from two employees

with \$2 million in sales to a company of 18 employees with \$15 million in sales.

Brian was highly involved in his local community through Jaycees, as an elected member of the Church Pastoral Council, and coaching Soccer, T-Ball, Baseball and Gymnastics. In 1979 he was the Indiana State Champion in high school gymnastics on parallel bars, an experience that taught him hard work and dedication pays off. In 2005 he was recognized by the Boy Scouts of America as Scout Master leading the largest Scout Troop in Southern Indiana.

In addition to his professional accomplishments and community involvement, Brian has had a major impact on Theta Chapter as a leader within the Theta Alumni Corporation and Housing Corporation for the past 14 years. During this time, he has served as the Alumni Board Vice President and President for a combined nine years. Since 2016 he has served as the Theta Housing Board President. after the Theta Board split into Housing Board and Alumni Board. Not only has he been the sinew connecting the Theta Alumni, but also connecting the Theta Alumni Corporation with the National Fraternity. He is overseeing the complete rebuilding of the beloved "Castle on the Hill," built in 1927, into a residence that meets the needs of undergraduates Brothers in the 21st Century.

#### **BROTHER RICHARD T. FULTZ, ALPHA ALPHA '90**

Brother Fultz attended Lock Haven University where he was instrumental in the rechartering of the Alpha Alpha Chapter. He has served the Alpha Alpha Chapter as a member of the Alumni Corporation for 36 years.



After graduating from Lock Haven, he began his career in the United States Army rising to the rank of Lieutenant Colonel when he retired from service. In addition to his service Brother Fultz also worked to keep his local community safe as a member of the Pennsylvania State Police. He retired from the State Police in 2015. He currently

still serves his community as the Perry County Emergency Management Coordinator.

#### **BROTHER MICHAEL E. MUELLER, ETA '95**



Brother Mueller joined the Eta Chapter as part of the group of men who recolonized the Chapter in the Fall of 1993. As an undergraduate, leveraging his studies in accounting, he served as the Chapter's treasurer from recolonization until he moved to the alumni board immediately upon graduation. He has been involved with the Eta Alumni

Corporation and/or the Kappa Delta Rho Foundation since 1996 when he completed graduate school with a Master's

degree in Taxation. For 15 years he served as the treasurer of the Alumni Corporation, getting the Chapter house re-established, remodeled and onto firm financial footing. During his time on the alumni board, he was instrumental in helping that board establish three scholarships which have been awarded annually for 20 years. He has been active within the Kappa Delta Rho Foundation for over 25 years. During this time, he has served as the President of the Foundation, Vice-President of Investments, chair of the Nominating Committee and for the last decade has been the chair of the Scholarship Committee which has over \$110,000 in scholarships to award this year.

Professionally, Michael started his career with Arthur Andersen, LLP before moving to a boutique accounting firm that focused on healthcare. He left the CPA world and has served in executive healthcare finance roles with a variety of healthcare systems including those that are for-profit, academic, non-profit and governmental. Currently, Brother Mueller serves as Chief Financial Officer for Orlando Regional Medical Center in Orlando, Florida, which is an 808-bed tertiary care academic medical center serving as the only Level 1 Trauma Center in Central Florida with more than \$1.5 Billion in annual revenue and the flagship hospital for Orlando Health. In addition to his normal CFO role, he enjoys teaching and mentoring healthcare leaders serving as an instructor for a variety of finance classes such as Finance Basics who are new leaders, Emerging Leaders and Advanced Leaders which are hospital executives or physicians and is a co-founder of the finance leadership year-long development program at Orlando Health. He has won CFO of the Year by the Orlando Business Journal.

Michael is currently Treasurer of the Heart of Florida United Way, Finance Chair and member of the Executive Board for the YMCA of Central Florida and serves on the finance committee for St. James Cathedral. In addition, he has previously volunteered with a variety of community not-for-profit organizations including as Treasurer of the West Orange Health Alliance, President and Treasurer of the Dana-Thomas House Foundation. He also coached his daughter's softball team for numerous seasons. He stays fit by playing in a weekly over 30 men's soccer league and has been blessed to enjoy each day of being married to his wife Renee for over 26 years.

#### **BROTHER WILLIAM P. OTT, SIGMA '66**

At an early age, Brother Ott showed an entrepreneurial spirit. He grew up on a small farm that supplemented his father's income from the Oregon logging industry. While it was not a large farm, Bill found ways to not only contribute to the family income but also to generate income for himself. Every day before and after school, Brother Ott milked his family's 35 dairy cows, storing the milk in chilled 10-gallon containers until the dairy co-op picked up the milk for processing. Based on this experience that began when he was 12, in the late 1950's Bill began to raise his own livestock which would eventually generate about \$400 every three months. He began raising turkeys and pigs for sale. Bill started with 500 turkeys as a freshman in high school, eventually increasing his flock to 10,000



turkeys by his senior year. He also raised about 40 pigs a year for sale, planting and harvesting the feed for his livestock. In high school, he was a member of Future Farmers of America (FFA) and was recognized as one of six high school juniors statewide to receive the FFA Award for achievement in Agriculture. Bill served as FFA Chapter President,

FFA Oregon State Dairy Judging Champion, and 5th place in the National Dairy Judging boards. Additionally, he has provided training to state transportation department about the DRBF processes.

Bill has also garnered the respect of the construction industry and has been named to numerous committees of the Association of General Contractors (AGC) and has served as trustee on several union pension funds and apprenticeship programs. Brother Ott was an active member of the Sigma Chapter during his undergraduate years (1960-66) and he has remained an active Alumnus. For the last 57 years, since 1962, Bill has organized a gathering of Sigma KDRs for a New Year's Eve gathering. He has been active with the Sigma Alumni Association since 2011, serving as the Association Vice President until 2013 and later as President.

Bill's entrepreneurial spirit rose again after he finished his engineering and agriculture degree at Oregon State University. He began working in the heavy civil construction industry for the Guy F. Atkinson Company until 1973 in field project management where he learned the details of working on horizontal construction. Bill went to work for MOWAT Construction in 1973 until 1998. He started as a project manager and was promoted to Vice President of the company in 1997. During his tenure at MOWAT, the company became a regional construction company successfully constructing projects in Washington, Oregon, Idaho, California and Alaska. After his retirement from MOWAT, he formed William P. Ott/Ott Construction Consultants, an alternative dispute resolution service, also offering value engineering, risk assessments, project scheduling, traffic phasing, construct ability, and project estimating. In addition, in 2016, he formed Ott-Sakai & Associates which continues to provide these services. Both enterprises are thriving and successful businesses that help construction companies and state transportation departments work more fairly, efficiently and effectively. Brother Ott helped develop and foster a unique approach to problem solving in the Construction Industry known as "Partnering" and has become a recognized alternative dispute resolution expert in the Western United States. The Partnering approach has become a fixture of large construction contracts where a method for resolving disputes, during the project, are established in advance of the start and is a product of agreement between the project owner and the construction contractor. His alternative dispute resolution work includes sitting on over 220 boards to review disputes between the Owner and the Contractor, chairing 67 of these.

#### **BROTHER CRAIG B. PETERSON, SIGMA '74**

As president of the Sigma Chapter during the summer of 1973, Craig faced a daunting challenge – the Chapter had only 4-8 returning members and 12 were needed to keep the Chapter doors open. That summer, along with three other members, Craig organized and successfully ran a recruitment effort that yielded 12 new pledges the Fall of 1973. Those 12 pledges (which outnumbered the returning by a ratio of 3 to 1) would serve as the nucleus of future successful recruitment efforts that saw the Chapter grow to 42 live in members at the Chapter house in less than seven years. Craig's leadership as Worthy Consul was instrumental in reviving the Sigma Chapter.



After graduating from Oregon State University in 1974, Craig went to work for INTEL in Santa Clara, California, and then in Portland, Oregon. He rose to the position of General Manager of INTEL Supercomputer Interconnect Components and Intel Microelectronics. Craig joined INTEL when it was only 6 years old and grew with

the company, contributing to many of its innovative products and services. During his 29 years at INTEL, Brother Peterson drove the design & development of three processors, eight generations of various chipsets, and a whole host of new technologies, and created his first three startup businesses inside Intel. Virtually every piece of electronics in the world has things that Craig invented. One of the INTEL startups was the original core team of what is now the third largest and most profitable businesses at INTEL. This startup was established with little support inside INTEL. Brother Peterson and his team changed the direction of the company and the digital world as we know it. Craig is an eight-time entrepreneur, three inside Intel, two in China, and now three in the Austin, Texas, area. Craig is currently the CEO and Founder of VEFXi Corporation, Aurra Corporation, & VIZN Gaming Corporation. VEFXi is the leader in high-quality real-time conversion of conventional 2D video & gaming to 1) Holographic 3D video; 2) 360 3D VR Video; and 3) Augmented reality systems. VEFXi is demonstrating its artificially intelligent Application-Specific Neural-Net technology used in its 3rd generation of converters. VEFXi holds 16 patents and 4 additional patents pending. VEFXi has sold previous generation systems to more than 30 countries. VEFXi is currently supporting customers in holographic-like digital signage displays, 360 3D VR gaming, and large-scale interactive augmented-reality displays with no headsets. Aurra Corporation has developed a holographic 3D LED wall called a Hologram Wall. Conventional LED walls are large video signs in sports stadiums, concerts, malls, airports, museums, and stage productions. Aurra has developed the first 3D with no glasses or goggles. Hologram Walls can create holographic experiences that can extend up to 8 to 12 feet in front of the wall. With off-the-shelf VR technology, a life-like solid-looking avatar can be placed

in a room and interact with the people inside the room, all with no glasses or goggles. Aurra is now selling a second product line selling the world's largest and most advanced Virtual Production Studio Chambers. These recently became popular after seeing the huge productivity and cost reduction using a smaller chamber at Disney made by Industrial Light & Magic. Aurra's chambers have the most advanced hardware and virtual production software in the industry. VIZN Gaming has developed a working demo of UltraVR which real-time converts much of the last 30 years of video games into full 360 3DVirtual Reality. This puts the player inside their favorite video game. And it can do this with eight times more pixel resolution than is possible with today's VR technology. One of the previous startups Craig leads was funded by the Defense Advanced Research Projects Agency (DARPA) with a \$12M contract and second contract was funded by DARPA at \$70M. This last DARPA contract represented one of their largest programs at that time. It was the beginning of the INTEL Enterprise business. Founded in 1968, INTEL is an American multinational corporation and technology company headquartered in Santa Clara, California, in Silicon Valley. It is the world's largest, and highest valued semiconductor chip manufacturer based on revenue, and is the inventor of the x86series of microprocessors, the processors found in most personal computers (PCs). Intel ranked No. 46 in the 2018 Fortune 500 list of the largest United States corporations by total revenue.

#### **BROTHER GAETANO P. PICCIRILLI, XI ALPHA'01**

Brother Piccirilli joined the Xi Alpha Chapter in the Spring of 1998. Unfortunately, the Chapter was closed shortly after due to failure to thrive at the time. He graduated from Temple University with his Bachelor of Arts in 2001 and then attend Temple University's Beasley School of Law in 2004.



Even though his undergraduate experience was not complete, his loyalty to Kappa Delta Rho never wavered. He has given generously to the Xi Alpha Chapter and the National Fraternity with his time and treasure. Brother Piccirilli was instrumental in the Chapter's return in 2009 and served as the Chapter's alumni advisor. He

was a founding member of the revitalized Xi Alpha Alumni Corporation that established the John J. Cobb Memorial Scholarship that will be awarded for the first time at this year's Scholarship Luncheon at the 106th National Convention in Malvern, Pa. Brother Piccirilli served on the National Board of Directors and is a member of the Heritage Society and Founders Society. In addition,he serves as an legal advisor and represented the National Fraternity in important and contentious litigation.

Brother Piccirilli is a business/commercial litigator with a distinguished law career complete with accomplishments and honors regionally and nationally, including the Legal

Intelligencer's "Rising Star" (2017) and "Unsung Hero" (2018). He has been ranked as a leading commercial litigator by Chambers & Partners and Best Lawyers. Currently, Brother Piccirilli is an equity partner at the law firm of Klehr Harrison Harvey Branzburg LLP. Brother Piccirilli has a reputation as an aggressive advocate with a thoughtful and responsive approach to representing clients in the state and federal courts of Pennsylvania, New York, and New Jersey. Chambers & Partners has described him as "an extremely strong litigator and advocate" for his clients.

Brother Piccirilli is active in the civic and non-profit realm. For 6 years he served as Board Chairperson of the Caring People Alliance (CPA), a large non-profit serving families and communities in Philadelphia. CPA is a member of the Boy's and Girl's Clubs of America is Philadelphia's Early Learning Resource Center, which coordinates the childcare subsidy program for the entire county. Yearly, CPA provides approximately \$250 million in services through contracts with governmental organizations, grants, and fundraising. The positive impact that CPA makes on more than 50,000 children and families is immeasurable. Brother Piccirilli was also an alumnus of CPA, having attended its South Philadelphia Community Center and Boy's and Girl's Club as a child.

Brother Piccirilli served on Mayor James Kenney's transition team for planning and development, and, in 2016 was appointed by the mayor to serve on the Philadelphia Tax Review Board, as a member of quasijudicial/administrative body responsible for all appeals city assessments, including but not limited to, business taxes, transfer tax, liquor tax, and parking taxes.. He completed his term in 2021.

Since 2019, Brother Piccirilli has served as a board member of the Delaware Valley Regional Economic Development Fund (DVREDF). DVREDF offers financing to a broad range of organizations and projects, such as helping a local non-profit grow its facility or aiding the launch of a local tourist attraction's ten-year strategic plan. Eligible enterprises include non-profit and for-profit entities, as well as certain public private partnerships.

In addition to his involvement with CPA and serving his beloved city of Philadelphia, Brother Piccirilli was appointed by Governors Rendell and Wolf to serve as member of the Pennsylvania State Real Estate Commission. In both instances, he was confirmed by the State Senate. In 2013, he was elected Chairperson of the State Real Estate Commission. The State Real Estate Commission is responsible for the regulation, licensure, and discipline of 50,000 real estate professionals in Pennsylvania.

Brother Piccirilli lives in Philadelphia with his wife Hadassah Piccirilli and three children, Nathaniel, Lyla, and Violet.

#### **BROTHER RICHARD D. READ, SIGMA '69**

Brother Read served Sigma KDR as Centurion during is his undergraduate years at Oregon State University



(OSU). Later, during his retirement, he came back to OSU and the reconstituted Sigma Chapter to mentor the Chapter leadership on leadership principles and skills. Rick continued his service to Sigma Chapter, first as a director of the Alumni Association and currently as the Vice President of the Association. Recently,

the Alumni Association highlighted in its publication *The Sigma Scoop* (and the *Quill & Scroll*) that Brother Read co-authored and provided critical information about two Sigma KDRs who were Missing in Action during the Vietnam War. His insights and detailed references helped complete the story of Brother Bob Nopp whose remains were recovered and Brother Bob Stanley who remains missing in action.

Military service is a tradition in Rick's family. His father was an Army Officer, as were his Brothers. Brother Read was commissioned in the United States Army after his graduation from OSU in 1969, during the height of the Vietnam War. After Officer Basic Training and the Ranger School, the newly minted LT. Read was deployed to the Republic of Vietnam where he served his country with honor and distinction. He was awarded the Bronze Star for meritorious service; the Air Medal with 3 Oak leaf clusters; the Army Commendation Medal; and Aircraft Crewmember Badge. After returning from the Republic of Vietnam, Rick continued his regular Army service at posts in Germany and Fort Sill, Oklahoma. In Germany, Captain Read was assigned to Wiley Barracks, Neu-Ulm, the 81st Field Artillery Regiment. This was a nuclear regiment, part of the Cold War deterrence that NATO had in place in Europe. Brother Read returned from Europe in 1974 to Fort Sill. A year later, Captain Read transitioned to the US Army Reserve and later to the Washington State National Guard. While at the Washington National Guard, Brother Read rose through the ranks from Captain to Brigadier General, commanding the 81st Infantry Brigade (Mechanized). Rick was awarded 2 Legion of Merit Awards in July 2000 and May 2002; Meritorious Service Medal (with 2 Oak Leaf Clusters) 1984, 1986 and 1991; and a 2nd Army Commendation Medal (with 2 Oak Leaf Clusters) 1980.

Brother Read's achievements in his military career are rare. Few military commissioned officers attain the rank of a general officer. After retiring from military service, Brother Read worked as a consultant for the Department of Defense from 2003 to 2009. He first led a team at Fort Lewis, WA, conducting a Congressionally mandated evaluation and certification of the Army's new Stryker Infantry Brigade. He then worked on a team reporting directly to an Assistant Secretary of Defense evaluating all aspects of Reserve Component mobilization and recommending required improvements. Since his retirement from military service in 2002, Brother Read has been active in community service in the communities around his home community of Redmond, Oregon. He has served on the Board of Directors of the Central Oregon

Chapter of Association of Military Officers since his full retirement in 2009. The Chapter supports Memorial Day events and competitive Junior Reserve Officer Training Corps Scholarships. Since 2011, Rick has also been active in the Employer Support for the National Guard and Reserve as a Team Leader and Member. This support groups helps local businesses, Guardsmen and Reservists adjust to the challenges of military service. During a time when the Guard and Reserve are part of the regular rotation into military service in combat zones, the support that Rick has provided in this role has made a significant difference.

#### **BROTHER RAFAEL S, SANCHEZ, EPSILON '92**

Brother Sanchez exemplifies what it means to be a professional. Brother Sanchez has worked at WRTV, an Indianapolis-based news channel, for over 24 years and counting. He has served as a news reporter, investigative reporter, and a news anchor. Rafael has earned five Emmys in reporting for the multitude of stories he presents with passion and excellence. He has been tasked with covering many stories, including the major 2008 Midwest floods in Franklin, Indiana, a story of the infamous bombing in Southport. Indiana, the death of a local police officer, and much more. Brother Sanchez also continues his professional excellence in the community of Franklin and the state of Indiana. He works with a multitude of nonprofit organizations to help them gain maximum benefit. His professionalism is a beacon on what a true professional is and what someone can do in a world full of pain and beauty.

#### Robert R. Saltzman, Beta '75



# Tragedy Impacts Us All! We Can Help!

I was originally going to compose an article updating you, the Brothers, on Foundation activities and the progress that we are making on the Brothers' Keeper capital campaign, as well as our strategic communication and outreach goals. Recent events, however, are weighing heavily on my mind and are driving my thoughts in a different direction. There was a recent tragedy at my alma mater, James Madison University, where a sophomore member of the JMU softball team unexpectedly passed away. Some of you may have been drawn in by the unexpected run that JMU's softball team made to the College World Series last year and the demonstrations of sportsmanship that were exhibited throughout. There was a sense of family on that team to which we can relate as a Fraternity. The details of her passing have not been disclosed, and honestly are not particularly important. The impact is being felt across campus and across the NCAA softball world. The outpouring of support for the friends, family and teammates is tremendous. The sadness that is provoked by the passing of someone so young and vibrant, however, weighs heavily on me and always leads to more questions than there are answers. It is hard to put your feelings into words at times like these. It can be difficult to know what to say or what to do. We feel for the people close to the young person.

Perhaps, it is because my children will be entering college soon, and the pressure that young people experience today hits very close to home. Or maybe, it is because I am very close to the young men in my Chapter at JMU and care very deeply about their well-being. Regardless, the loss of someone so young should evoke a strong emotional response and be a call to action to do something that prevents similar circumstances in the future. Our Fraternity came to this conclusion several years ago when the Brothers' Keeper Program was conceived and the capital campaign to fund Brothers' Keeper was established. Kappa Delta Rho averaged one suicide per year from 2009 to 2019, and leadership recognized that we had a duty and an obligation to our Brothers to provide them the necessary resources to help them deal with a crisis and support others that may be at risk. The Brothers' **Keeper Capital Campaign may be the most important** fundraising endeavor in our 116-year history! Do college campuses employ staff to provide counseling and other services in time of crisis? Of course. We know, however, that many college and university staffs are overwhelmed and underequipped to handle the increasing number of

students that seek help. One does not have to browse the various social media platforms long to see the glaring need for counseling and guidance during stressful life events. All too often students turn to alcohol and other drugs to relieve their stress and anxiety. Unfortunately, these situations can develop into more serious incidents such as self-harm or suicide. As a Fraternity, we **MUST** lead by providing our undergraduates with the skills to be able to minimize the negative outcomes of stress and anxiety and the resources they need to find help.

We are in a position to make a significant difference in the lives of our Brothers. It is incumbent on all of us to dedicate ourselves to the cause of supporting the mental and emotional health of our Brothers. Our Brothers need us, and we need to be there for them! Thus far, we have received more than \$1.45M in commitments from more than 300 supportive undergraduates, alumni, and parents. Nearly one-third of the donors are from Chapters that are closed; lifelong Brotherhood exemplified! We know there are many alumni who are pondering their level of commitment to the effort. Please consider supporting this campaign at https://www.kdr.com/foundation/brotherskeeper/. We all have our own stories as it relates to mental and emotional well-being. I will close with a quote from a Brother from Bucknell and his personal motivation for supporting Brothers' Keeper.

"Hannah and I have three young adult children (20, 22, 24) who are all healthy and doing well but two of them have benefited from mental health services over the years. I have had to ask the question to my kids at times, "Are you ok, are you safe?" Thank goodness, they are all doing very well. I know I personally went through a very dark period in medical school and thankfully with family, friends, and mental health services, I also came out the other side. The happy-go-lucky red-haired freckle-faced "Opie Cunningham" known to many of you at Bucknell, was not always so happy-go-lucky under the surface.

I simply felt a personal obligation to share my thoughts about this program with all of my experiences and if any of you have had similar experiences, this program seems like an opportunity to do something positive and help a very real problem our young people are facing."


