# A Lifetime of Impact; Because of You!

**W**e proudly present you with the 2022-23 edition of the Kappa Delta Rho Foundation Impact Report. The Constitution of the National Fraternity of Kappa Delta Rho states that “Kappa Delta Rho is a lifetime brotherhood dedicated to the continuing character development of its members through Fellowship, Leadership, Scholarship, Service, and Tradition.” This year, as we look back on 2022-23 and look forward to 2023-24, we wanted to highlight the “Lifetime of Impact” that our undergraduates receive from Alumni who live out our mission.

In recognition of this group of supportive Alumni, we are establishing and unveiling the lifetime giving society of Kappa Delta Rho: **the Cursus Honorum**. Cursus Honorum means “course of honors” or, less formally, “ladder of honor,” and the purpose of the Cursus Honorum is to recognize our most loyal supporters, both in terms of dollars contributed and years of giving. You can find more details on the Cursus Honorum later in this publication.

There are so many ways that we, as Alumni, can have a lifetime of impact on the undergraduate Members of our Order.

**Lifetime of Impact with Chapters** - Kappa Delta Rho is blessed to be filled with Alumni who care very deeply about their Fraternity and their Chapters. As Alumni, we can choose to give back through time, talent, and treasure. Many Alumni positively impact their Chapters as:

- Mentors and guides to the Chapter executive committees, passing along the knowledge of how to run a successful Chapter to our undergraduate Brothers.
- Officers and volunteers on Chapter Alumni Boards and Housing Corporations provide resources that improve the overall college experience for our Members.
- Some Alumni further the life skills of our undergraduate Brothers by offering career counseling and networking opportunities.
- Many Brothers choose to make an Impact by contributing to the Annual Fund of the Foundation.

The services that our Chapters enjoy from the National Office are a direct result of the funding that the Foundation receives from generous Alumni and friends. The National Office developed an online educational platform that allows the Chapters to conduct most of their new member education and Chapter business online. The leadership training that is conducted through the Consul's Academy and the Elmon Williams Leadership School could not have happened without your support. For that, we are grateful.

**Lifetime of Impact through Scholarships** - More Brothers than ever before are receiving financial assistance for their scholastic endeavors thanks to the generosity of Alumni and friends who

want to make a lifetime of impact on those who follow in their footsteps. We have many undergraduate members performing exceptionally well in and out of the classroom, in their Chapter, and in their community. In support of them:

- Over \$100,000 of endowed scholarships were distributed by the Foundation in 2023.
- Over \$1.7M has been dispensed to further the academic endeavors of Brothers of KDR since the Foundation's inception.
- Eight (8) new scholarship funds were created over the last three years in partnership with dedicated Alumni who provided financial support for members of their respective Chapters.

We expect to announce additional scholarships in 2023-24. **Our Fraternity is truly blessed!**

**Lifetime of Impact through Brothers' Keeper** - Alumni and friends have pledged over \$1.5M to the Brothers' Keeper capital campaign. College students today face complex challenges (only heightened by the impact of COVID), and it is not uncommon for students to turn to alcohol and other drugs to relieve their stress and anxiety. With your financial support, Kappa Delta Rho is leading the Greek community by providing our undergraduates with the mental health resources needed to minimize the negative outcomes of stress and anxiety and the resources they need to find help. Although the official campaign concluded in the Fall of 2022, the need is great, and we will keep driving this initiative until our \$2.5M goal is met. In closing, I want to thank the Foundation Trustees and the Fraternity Directors for the time and energy they give to our Brotherhood. The Trustees of the Kappa Delta Rho Foundation are dedicated to the work necessary to make our Fraternity stronger by raising the financial resources required to provide the services that our undergraduate members deserve. **You**, the donors, are the backbone of our Fraternity.

As we revert back to more in-person leadership training for the Consul's Academy and similar educational forums for Chapter Treasurers, Senior Tribunes, Junior Tribunes, and Secretaries, additional funding will be required. With your help, we can continue to make a **Lifetime of Impact**. The Kappa Delta Rho Foundation has experienced another noteworthy year. Among the Foundation's 28 years of history, this marked our 15th most successful year for the Annual Fund. With the support of donors like you, we are providing *A Lifetime of Impact* for our undergraduate and graduate Brothers.

We (Donors, Foundation, and Fraternity) consistently rise to meet the challenges posed by external situations and respond effectively, ensuring that our Fraternity continues to make a positive difference. Some of the notable accomplishments include:



and I toured Parks College of St. Louis University. Our guide was Ralph DePalma, a slender and confident aspiring USAF pilot from New York. Despite my initial uncertainty about college decisions, my dad, a USAF veteran from New York, immediately connected with him. Over the next 35 years, Brother DePalma (retired USAF Lt. Col, 30 years) and I bonded. Our connection endured from him recruiting me into KΔP to me serving as his best man and his daughter's godfather. He is one of my closest friends, as well as my fraternity Brother. In August 2023, I was in Normandy, France, visiting WWII cemeteries and battlegrounds with Brother DePalma and his parents,

- ✦ We raised \$122.8K for the Annual Fund, with support from 252 donors, including 86 new and former contributors.
- ✦ On Giving Tuesday (November 2022), we experienced another successful year, securing \$9.7K in donations for the Annual Fund from 32 generous contributors.
- ✦ On Founders' Day (May 2023), we gathered \$9.5K in contributions from 38 donors across 26 Chapters, which goes toward the Annual Fund.
- ✦ The Foundation disbursed over \$100K in endowed scholarships to 70-plus Brothers from 22 Chapters.

# A Financial Overview of the Kappa Delta Rho Foundation

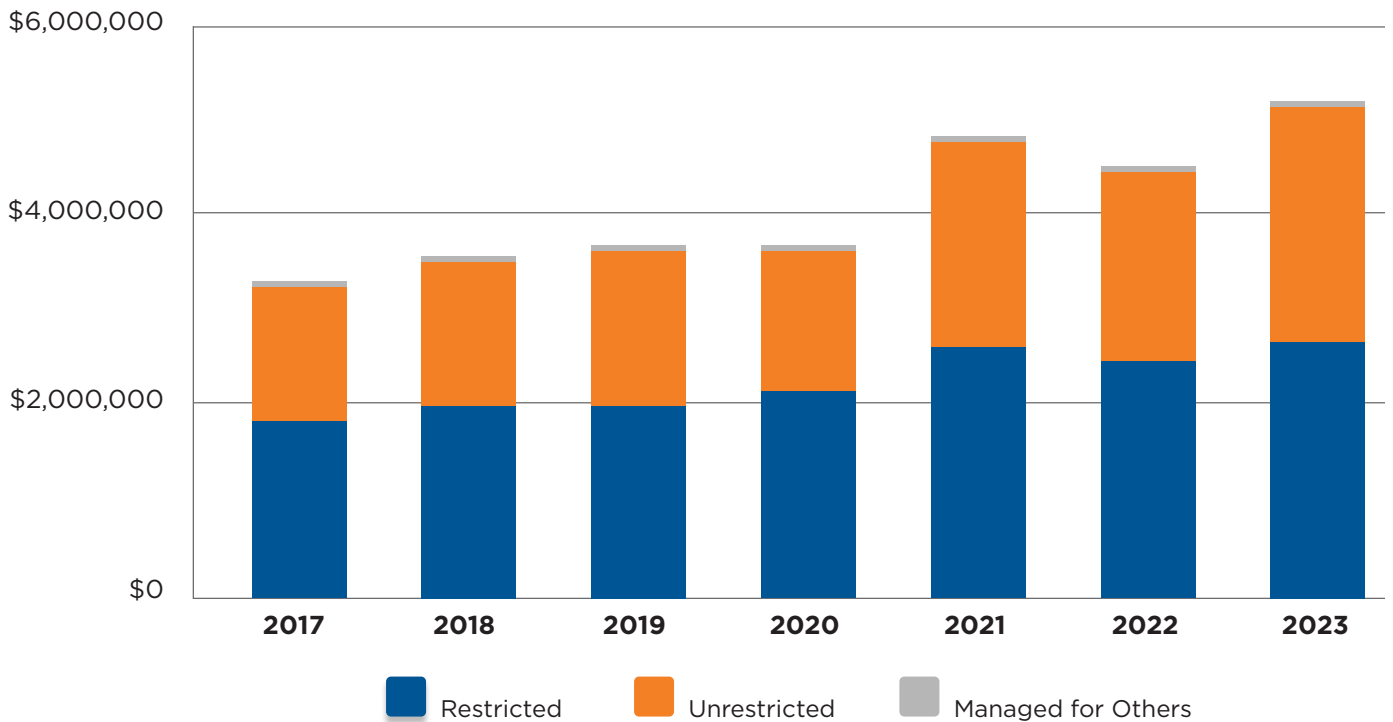

**T**he Kappa Delta Rho Foundation is a 501 (c)(3) charitable and educational corporation created to provide Alumni, Undergraduates, family, and friends of Kappa Delta Rho a means to give back and pay it forward for future Brothers of KDR. In most cases, funds contributed would be considered tax-deductible to the donors. These contributions provide the revenue from which the Foundation supports Member scholarships and the academic and character development programs of the National Fraternity.

With the generous support of our alums and friends, more than \$371,662 has been granted to the Fraternity for educational and leadership programming since 2017. In addition, \$486,683 in chapter-specific, field of study specific, and needs-based scholarships has been awarded to Kappa Delta Rho undergraduates and alums during this time.

## ASSETS UNDER MANAGEMENT (as of June 30, 2023)



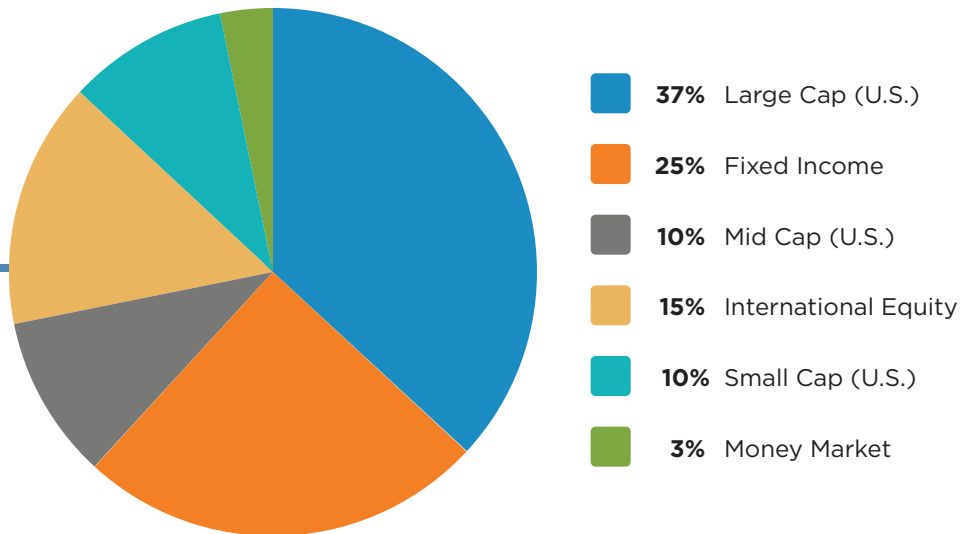
A primary responsibility of the Foundation is the management of the assets entrusted to us by the donors: past and present. The Foundation's Investment Committee supervises the management of all endowed funds. These funds include the general endowment, which supports the educational

programming of the Fraternity, as well as the numerous scholarships designated to support the ongoing education of our active members and alums pursuing undergraduate and graduate degrees.

The Foundation fully supports the creation and endowment of new scholarships and has established policies governing restricted purpose and endowment funds consistent with applicable law. We account for these assets in separate funds based on fund purposes and donor-imposed restrictions. The Foundation seeks to preserve the corpus and utilize only earnings for all endowment funds with a current maximum payout rate of 5% (as defined in its Investment Policy Statement, revised 2011). An endowment fund is formed only upon the creation and acceptance by the Foundation of an Endowment Fund Agreement that conforms to relevant policy. We welcome the opportunity to provide additional information to those interested in the

rewarding experience of creating an endowed fund to provide scholarships for current and future students.

Another service the Foundation provides is offering short-term loans to Chapters in need through the Chapter Loan Fund. The Trustees established this Fund to make loans to aid Chapters or alums corporations of the Fraternity in building, remodeling, purchasing, financing, or refinancing Chapter houses or acquiring equipment, furnishings, or fixtures for the Chapter. All loan repayments, including interest, are retained within the Fund and recycled for future Chapter loans.

# Chapter Loan Fund: Keeping our Chapters Competitive

## Case Study (Pi Alpha, Toledo University)

**I**n 2013, Pi Alpha began a journey to restore the Chapter to its former glory. This journey included restoring Pi Alpha House. The University of Toledo built the house first occupied by Brothers in the Fall of 1990. Over the years, the house fell into disrepair. Unfortunately, our alumni base was small in numbers and young in age. Where can we turn for a \$23,000 loan to help restore the house? The KΔP Foundation. In August 2018, after several years of rebuilding the Chapter, our Consul Dan Shopshire and Quaester Tony D'Amico stood before the KΔP Foundation Board and made their case. The Foundation was impressed with the strength and financial plan of the Chapter and granted Pi Alpha's loan request of \$23,000. That money was combined with \$5,000 from The University of Toledo and \$2,000 from Chapter fundraising. In three short weeks, Pi Alpha spent nearly \$30,000 to install a new wood plank floor, buy a massive sectional sofa that seats 16 people, and purchase new TVs. Alumni Brothers contributed "sweat equity" as well, spending a weekend building seven tables and a television stand to help save money. New study chairs and an Executive Committee table and chairs were also purchased., Pi Alpha Brothers returned to campus in

the Fall of 2018 to a "new" Pi Alpha House. It went from being the worst house on campus to the best overnight. The past five Pi Alpha executive committees have done an excellent fundraising job of investing between \$5,000 and \$15,000 in the house each summer. We've built a three-year furniture rotation plan. We replace the furniture on the first floor every three years and move the old furniture to the basement. This enables the Chapter to have two sectional sofa or TV areas that are clean and functional.

The Chapter Loan Fund was established by the Foundation Trustees to make loans as an aid to Chapters or Alumni Corporations of the Fraternity in building, remodeling, purchasing, financing, or refinancing Chapter houses or for acquiring equipment, furnishings, or fixtures for the Chapter. The motivation for creating the Fund was to help Chapters maintain a competitive edge on their campus. Pi Alpha is grateful to the KΔP Foundation. The loan gave Pi Alpha the edge to speed up our recruiting and recovery efforts dramatically. Pi Alpha paid off the loan in September 2023 and plans our next major renovations.

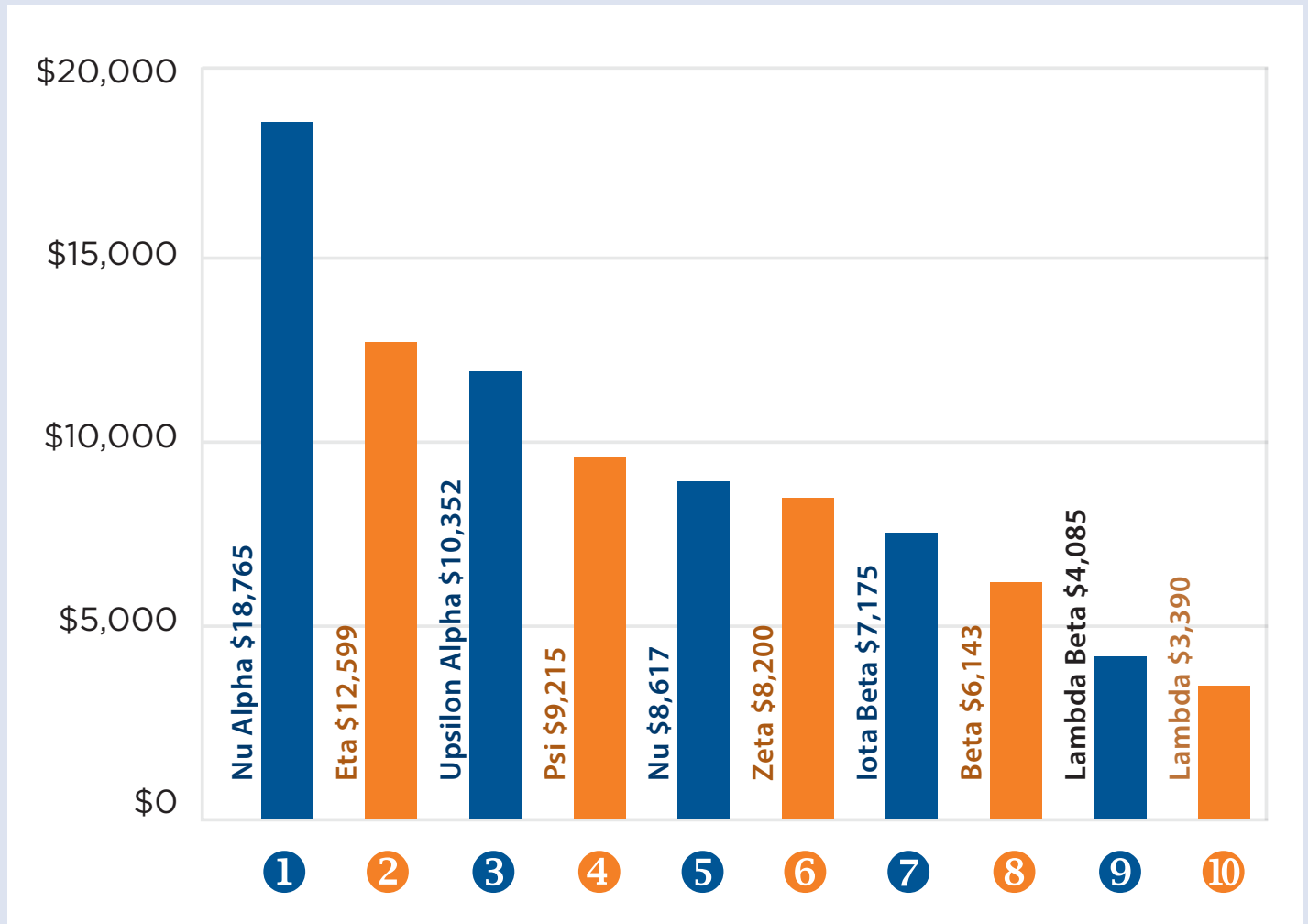

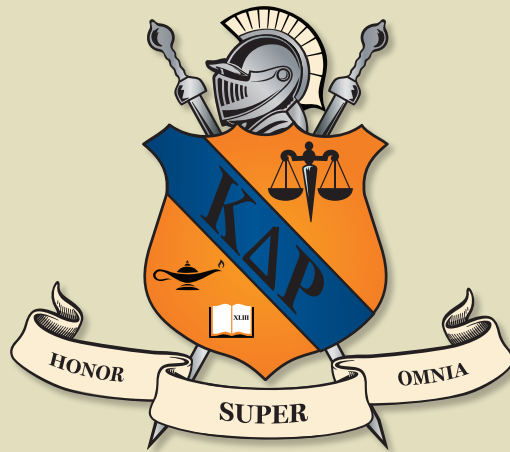
# TOP CHAPTERS BY TOTAL DOLLARS GIVEN

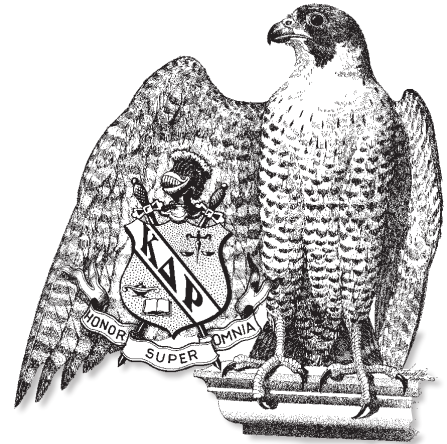

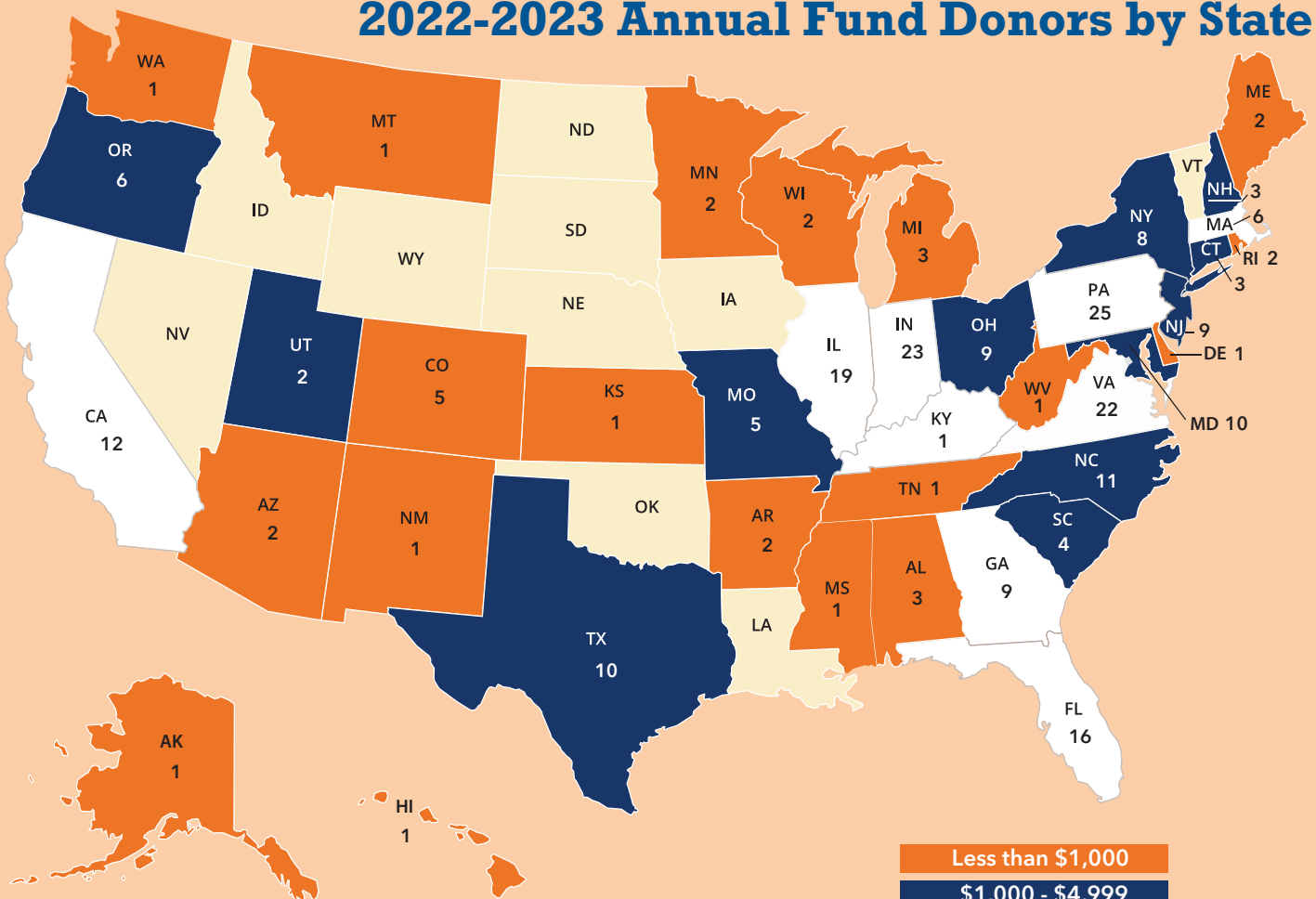
